Welcome

Heidi welcomed everybody to the WebEx meeting and introduced our guest speaker.

RedakTec Presentation

Our guest speaker, Rick Meyler, was recommended by Mike Liddicoat.

Rick was manager of technical support for EndNote before he founded RedakTec, two years ago. Redak Tec is looking at the integrity of scientific research by looking at the number of retracted articles that are being cited in a research article. Articles could be retracted because of plagiarism, fraud, data error, or bad methodology. Redak Tec also looks at self-citing authors, journals that do not retract articles, etc. The number of retracted articles is increasing.

RedakTec uses the Microsoft Academic Database from 2018 as data source to build the software. They hope to have the product finished, end of the year.

Rick Meyler wants to make it free for us, then \$1/month per researcher. They plan to charge publishers and institutions. They work with some librarians. The software will work on top of other databases, also on preprint and OA servers.

Lisa: virtual during Winter semester. Goes one day/week to library. She shifted the budget to buy e-books and other e-resources.
